It's time to register your child for our exciting summer program! Your child will have a great time playing with his/her friends and make some new friends too. Your child is a blessing to us, and, in return, we hope we will be a blessing to you and your family.

Here is some information regarding our summer program:

Sessions and Fees:

Full Day (7:00 a.m. - 6:00 p.m.)

Half Day (7:00 a.m. – 12:15 p.m.)

Drop-off time is between 7:00 a.m. – 8:45 a.m.

Registration Fee: \$55.00 (due Friday, May 6th)

Full Day	5 Days \$170/wk	3 Day \$125/wk	2 Days \$90/wk
Half Day	5 Days \$125/wk	3 Days \$85/wk	2 Days \$55/wk

Tuition is due at the beginning of each week your child attends. You may pay weekly or for a longer period of time, if you wish. Please notify the preschool director if you need to make any changes to your summer session request at least one week in advance, otherwise you will have pay for what you originally signed up for. There is a 10% tuition discount for a second child in preschool. Please make checks payable to Christ Lutheran Preschool and bring them in to the preschool office. Returned checks will be subject to a \$25.00 fee.

For students already enrolled in our program, you only need to complete the attached Summer Registration form and the Sunscreen Permission form. For new students to our program, please complete the California State forms located on our website (www.christcm.com, under preschool registration information) as well as the attached summer registration form and Sunscreen Permission form. Please check the weeks that you are interested in, indicating which days of the week your child will attend, and whether your child will attend full days or half days. The summer registration fee and forms are due **Friday, May 6th**. When we receive the registration fee of \$55.00, and the necessary forms, a place is reserved for your child in our summer program.
